## **Key Points of Facilities Subject to the Health Promotion Act** and Tokyo Metropolitan Ordinance

■ No smoking on the premises/ No smoking indoors (Smoking area installation not allowed)

Specified outdoor smoking areas can be installed outdoors

■ Schools, hospitals, clinics, child welfare facilities, government administrative agencies, etc \*However, it is prohibited (as a duty to make efforts) to install smoking areas outdoors at kindergartens, nursery schools, and elementary, junior high, and high schools.

\*Buses, taxis, and airplanes are non-smoking inside the car (or airplane).

■ No smoking indoors/ Non-smoking or the establishment of a designated smoking room or a designated heated tobacco smoking room

Facilities used by 2 or more people
Offices, factories, hotels, Ryokans, passenger ships,
passenger trains, and restaurants with employees

\*Restaurants without employees can choose between no indoor smoking or smoking.

<sup>\*</sup> If you install a smoking room, you are obliged to post appropriate signs at the entrance and exit of the smoking room and at the storefront.

In addition, restaurants are also obliged to post non-smoking signs at the storefront if they are non-smoking.

■ Specified facilities: Type I facilities, Type II facilities, and facility for smokers

	Metropolitan Designated Specific Food and Beverage Provision Facility (Tokyo Metropolitan Ordinance, Article 2-6)	Facilities such as restaurants and coffee shops that meet the following four requirements  1) As of April 1, 2020, the business was already in operation, 2) having a seating area of 100 square meters or less, 3) operated by a small or medium-sized enterprise (with capital or total investment not exceeding 50 million yen) or individually, 4) and is a facility that does not employ employees (workers as defined in Article 9 of the Labor Standards Act).  *Those who are paid wages (excluding cohabiting relatives, etc.)

- Specified outdoor smoking area: Part of the outdoor area of a Type I facility that has been demarcated as a non-smoking area by the managing authority and where the necessary measures to prevent second-hand smoke (\*), as stipulated by regulations, have been implemented
- \* Measures necessary to prevent second-hand smoke in specified outdoor smoking area [Article 15 of the Enforcement Regulations of the Health Promotion Act]
  - 1) There must be a notice indicating that this is a smoking area
  - 2) It must be installed in a place where users of the Type I facilities don't usually enter
